## **RULES**

No cotton will be delivered or loaded until receipts have been surrendered.

This tariff is subject to change in accordance with U.S. Warehouse Act regulations.

All accrued charges will be invoiced at time of shipment to party surrendering warehouse receipts and are due and payable upon presentation of the invoice.

Accrued charges are due and payable on cotton in storage at end of cotton season.

All cotton received in wet, muddy or damaged condition will be put in condition immediately and the storer will be charged for the service.

When wet cotton is weighed, weighers will exercise their best judgment in making deductions.

All cotton is fully insured against loss or damage by fire and lightning under the standard form of fire insurance policy approved for Federally licensed cotton warehousemen.

This Corporation is not liable or responsible for accidents, delays in handling caused by strikes, labor disputes, shortage of labor, or any other cause beyond its control, concealed damage, water packs, gin falls, dampness, any irregular condition not apparent, Acts of Providence, or acts of public enemy except as otherwise required by U.S. Warehouse Act and regulations thereunder.
